Instructions for Applying:

1. Complete the Application for Admissions in its entirety.
2. Email or mail images of your portfolio, recently completed works or relevant experience to admissions@iyrs.edu or mail to:

3. Obtain and provide two professional letters of recommendation, preferably from an employer or school teacher. Letters can be prepared using the included cover sheet or sent directly to the IYRS Office of Admissions. Additionally, letters of recommendation will be accepted by email providing the reference comes directly from the recommender. Letters should be sent to admission@iyrs.edu.
4. Provide an official high school transcript, GED or college transcript. Applicants must demonstrate successful completion of the high school diploma. If an applicant has completed more than 15 college credits at the time of application, official college transcripts must also be received.
5. International student applicants should complete the Personal Statement within the application.

Once the above information is submitted to IYRS, students will be asked to complete an in-person interview with an admissions representative. The purpose of the interview is to share information with applicants, as well as learn more about an applicant's interest in their program of application and demonstrated aptitude for successful completion of that program. Applicants who are unable to travel to IYRS may make arrangements for an alternate phone or Skype interview.

Once an applicant has completed their interview, the application will be submitted to the admissions committee for review and an admissions decision will be provided to the applicant as soon as possible.

Students are selected without regard to national or ethnic origin, race, sex, age, sexual orientation or religion and must be capable of benefiting from the training offered. International Student Admission Instructions and Addendum

Instructions to International Student Applicants: Thank you for considering IYRS. Every year students from around the world join our community and train for rewarding careers across multiple industries. We look forward to working with you and welcoming you in the near future.

International student applicants who are not citizens of the United States, including resident aliens, are required to obtain a non-immigrant student visa in the M-1 category. M-1 is a category designated for international students who attend a vocational school.

Once you are accepted and enrolled at IYRS we will send you a SEVIS Form I-20. This is a Certificate of Eligibility for Non-Immigrant Students that certifies your enrollment. You will need the Form I-20, along with other documentation to apply for your M-1 visa. More detailed instructions on how to apply for an M-1 visa are available from the IYRS Office of Student Affairs.

The M-1 student visa is valid for a maximum of twelve months at a time. If you are attending a two-year program at IYRS, you will need to request a program extension for each year of enrollment or apply for a new M-1 visa. The IYRS Office of Student Affairs can help you with this process.

Along with your complete application for admissions, you must fill out the following in order to complete your application to IYRS.

- 1. Personal Data Statement:** This information is required so that we can certify you as a student and complete your I-20 form, the first step in acquiring your M-1 visa.
- 2. Declaration of Financial Resources/Affidavit of Support:** Complete this form and provide the required documentation.
- 3. Transcript Translation and Certification:** High school or college transcripts must be translated and certified to determine the U.S. equivalency. A high school education by U.S. standards is required by IYRS. The last page of this document lists the approved agencies.
